- Vendor Agreement -

Agreement: Upon execution by both parties, this Agreement shall constitute a binding agreement between Kiwanis Club of Redlands-Morning Foundation and its related entities and _____ (“Vendor”), whereby Kiwanis Club of Redlands-Morning Foundation agrees to rent vendor space to Vendor at the 1st Annual Redlands Morning Kiwanis Rib Cook-Off event on Saturday, September 4, 2010 at Sylvan Park (University Street and Colton Avenue) in Redlands, CA, pursuant to the terms contained herein. Any changes or additions to this Agreement must be in writing and executed by both Kiwanis Club of Redlands-Morning Foundation and Vendor to be valid.

Space Allocation: Vendor understands that vendor space allocation shall be at the sole discretion of Kiwanis Club of Redlands-Morning Foundation. Vendor spaces are available on a first-come, first-serve basis. Kiwanis Club of Redlands Morning will make every reasonable attempt to grant requests for assignment of specific vendor location whenever possible. Order of preference is assigned based on the date the Kiwanis Club of Redlands Morning receives a completed Vendor Booth Application along with the agreed upon fee.

Payment of fees: Confirmation of vendor space is subject to receipt by the Kiwanis Club of Redlands-Morning Foundation of a completed Vendor Agreement accompanied by payment of all space fees. No refunds will be issued for any reason after August 15, 2010.

Permits and Insurance: Vendor shall comply with all the California State Laws and local ordinances regarding the sale of merchandise and/or food. Vendor agrees to obtain, at its sole expense, any sales, health or other permits that may be required for participation in 1st Annual Firefighter’s Rib Cook-Off.

Taxes: Vendor agrees to be responsible for collecting and distributing to the proper agency(ies) any applicable state/local taxes.

Release: I, _____, Vendor, agrees to release, indemnify and hold harmless the Kiwanis Club of Redlands-Morning Foundation and its respective related entities and representatives including, but not limited to, their officers, agents, employees, contractors, committee members, volunteers, guests, patrons and/or staff from any and all liability, injury or damage which may result from acts, omissions or negligence of any person or entity during Vendor’s participation in 1st Annual Redlands Morning Kiwanis Rib Cook-Off on September 4, 2010, including event preparation, participation and clean-up. This release shall include, but not limited to, any injury or damages in that may stem from personal injury or loss of life, loss of property, theft, damage by fire, or any other causes that might be suffered by Vendor, its agents, officers, employees, contractors, invitees, patrons or guests.

Vendor hereby confirms and acknowledges that it holds current and adequate liability insurance.
